We will be presenting a financial update as well as news on future plans for Bloomingfoods at our member forum on Monday, July 23rd at 7:00pm (location to be determined). Please join us to celebrate our 42nd birthday and continue our work for the future. We'll also be handing out birthday cake in the stores! We also encourage you to participate in the public input sessions being held by Trinitas, the developer who will be developing a 12-acre parcel currently occupied by K-Mart and Bloomingfoods. Come tell them what you'd like to see! Local? Green? Sustainable? A new home for Bloomingfoods? Workshops will be held at Binford Elementary School on 2nd Street from July 23-30 and comments will also be accepted online. We will post more details on our website and Facebook as they become available.

Did you enjoy Co-op Day? Several members asked me what it's all about so here are my thoughts on our newest quarterly event. Co-op Day is a celebration of our cooperative and the Bloomingfoods community. It is a time to have fun, to show appreciation for our members, and to invite new members to join. (13 new members joined on Co-op Day!) We haven't always made time for celebration during our last few years of struggles and it's time for that to change. Hopefully you enjoyed the live music, free ice cream, adorable baby goats, special sale pricing, and the amazing selection of local samples. Our goal is to celebrate all the people who make Bloomingfoods a wonderful place – our members, our vendors, and our staff. Thank you to all who participated and we hope to see you at the next Co-op Day in September!

In other board news, we recently updated our Ends statement. Did you know Bloomingfoods has an Ends statement? Do you know what it says? Our Ends statement is essentially our mission statement that guides what we do as a cooperative. After several months of deliberation and discussion, the board is pleased to announce an updated version that we feel best reflects the goals of the cooperative. Because of BCS, people in Bloomington and South Central Indiana will have...

- A market for local, fair and healthful products, produced with care for the land, animals, and future generations.
- A democratic cooperative-ownership model that provides meaningful employment and strengthens the community.
- A robust and sustainable local food economy with fair prices for producers and all owner-members.
- Access to education on food systems, cooperative values, and the interconnectedness of food, health, and the environment.

What did we change? We added language to emphasize that we are interested in the sustainability of how our food is produced, which may go beyond organic certification. We directly expressed the importance of providing meaningful employment that meets the needs of our staff. We emphasized our big picture goal of building a sustainable local food economy which involves much more than just a grocery store. Last but not least, we clarified our role in providing education about the local food system and how our choices as consumers impact the world around us.

Look for our updated Ends statement in the stores and future discussion of how we are working towards each goal. The future is exciting and we continue to be optimistic about our role in the community and our ability to improve the health of our food economy while meeting the needs of our members.


